The IDI measures an individual's fundamental worldview orientation to cultural difference, and thus the individual's capacity for intercultural competence. The more ethnorelative the worldview, the more likely the individual's attitudes, knowledge and behaviors constitute intercultural competence. There is a \$60 charge for the first IDI test and an additional \$10 for each test thereafter.

The tool contains 25 items, 5 questions each measuring the five cultural constructs of desire, awareness, knowledge, skill and encounters. Each question is rated on a 4 point Likert scale with higher scores depicting a high level of cultural competence. There is an \$8 fee for each test.
